Juniors:		\$5 for each junior under the age of 18.

Annual Dues: \$125 per year. The amount due upon joining is pro-rated. Jan-Mar \$100; Apr-Aug: \$5/ month discount; Sept-Dec \$100, but this covers the dues for the following year also. Seniors (62 and over), annual dues are \$75. A \$30 dollar discount to members with valid membership with the NRA or Goal or a 2nd amendment organization approved by the Board
 Work Incentive: Four hours of sanctioned work are required annually or a \$100 fee will be added to dues upon renewal.
