Article 5 Section 3: Previously stated; Each meeting shall be called to order at 8:00 PM. Will be changed to; Each meeting shall be called to order at 7:30 PM

Article 7 Section 2: Previously stated; The Board shall meet on the second Monday of each month at the principal office of the association or as designated by the President. **Club Policy and Dues:** Dues will change to \$125 for members and \$75 for seniors. A \$30 discount will be given to members with a valid membership with the NRA, GOAL, or a 2<sup>nd</sup> Amendment Organization approved by the board.

**Certain Range Rules:** Add the following to Rule 3: All Guests must fill out the Liability Release & Indemnity Agreement form and club member must sign.

Add new line to Rule 18: No one may operate a firearm if they consumed alcohol or drugs, that impair their ability to safely operate machinery or drive.

Change the number of rounds allowed in a firearm to; There will be no limit unless directed by a range officer during an event to load a limited number of rounds.
